- **S. R. O. 1216(I)/2021.** In exercise of the powers conferred by section 25 of the Public Private Partnership Authority Act, 2017 (VIII of 2017), the Federal Government with the approval of the Board of Directors of the Public Private Partnership Authority, is pleased to make the following rules, namely:—
- 1. **Short title and commencement**.—(1) These rules shall be called the **Public Private Partnership Authority Working Party Rules, 2021.**
 - (2) They shall come into force at once.
- 2. **Definitions.**—(1) In these rules, unless there is anything repugnant in the subject or context,—

- (a) "Act" means the Public Private Partnership Authority Act, 2017 (VIII of 2017);
- (b) **"Chief Executive Officer"** means the Chief Executive Officer of the Authority appointed under section 7 of the Act; and
- (c) "member" means member of P3WP.
- (2) All other words and expressions used in these rules but not defined herein shall have the same meanings assigned thereto in the Act.
- 3. **Composition of P3WP**.—(1) The P3WP is hereby established with the following members, namely:—

- (2) The members from the private sector, referred to in sub-rule (1), shall be appointed by the Board for a period of three years in accordance with sub-rule (3) and subject to such other terms and conditions as the Board may determine.
- (3) The members from the private sector shall be known for their integrity, expertise, eminence and shall have experience of not less than ten years

in any relevant field including industry, commerce, economics, finance, law, accountancy or public administration.

- (4) The Chief Executive Officer P3A shall be the Secretary of the P3WP.
- (5) P3WP may, when considering a matter for which it is responsible under the Act, require the Secretary of the concerned line Division or his nominee not below the rank of Additional Secretary or equivalent or the head of the concerned autonomous body, to be present in such meeting of the P3WP as an observer to perform such roles and functions as may be required in connection with the matter.
